MPI


- Market potential index (MPI) measures the probable demand for a product or service within a defined service area
- MPI shows the likelihood that an adult resident will participate in certain activities when compared to the U.S. National average
- Provided by the environmental systems research institute (ESRI)
- The national average is 100; therefore, numbers below 100 would represent lower than average participation rates (lower demand), and numbers above 100 would represent above average participation rates (higher demand)










What is your gender?








What age segment are you in?















What zip code do you live in?

Strengths

Facilities and Amenities

A variety of well-maintained grounds and facilities, including the dog park, pool, baseball fields, skate park, new community center, and walking trails/pathways

Overall Aesthetics and Layout

• The space and natural beauty the park provides and appreciate the effort to maintain it

Staff

• The knowledge, service and passion of parks, recreation and cultural services staff

Variety of Activities

• The variety of programs, services, and opportunities available to users of all ages







Opportunities

Accessibility & Connectivity

"Accessibility" in terms of every person's ability to utilize the park (including ADA) and all it's amenities, "connectivity" in its ability to connect users to the park in a non-motorized manner

Lack of Shade

The lack of trees and shade structures, especially around high use park amenities, combined with the warm climate has a negative impact on users enjoyment of the park

Layout

 Concerns included space allocation, parking (mentioned above), lack of restrooms in some places, and which areas are underutilized (e.g., Bocce Ball courts)

Parking

 Would like to see improvements made to not only to the amount of parking, but to the layout and lighting of the existing lots

Public Awareness

Concerns were addressed that there are portions of the population that are unaware of Community Park's services, programs, and even location







Top Priorities

Open Space

More space available for unstructured or free activities that allow users to enjoy the natural beauty of the park

Park Entrance/First Impression

Stakeholders would like to see the entrance be more open with better sightlines and believe it would improve the first impression of the park

Multi-Generational Facilities and Amenities

Many participants in the key stakeholder and focus group interviews wanted to see the addition of Multi-Generational Facilities and Amenities, such as pickleball courts

Shade

Addition of both shade structures and more trees to make visiting the park more enjoyable

Trails/Connectivity

Participants mentioned wanting more trails, pathways, and walking paths as well as better connectivity to the natural areas




When do you or any member of your household typically visit Community Park? (select all that apply)








Who do you usually go to the Community Park with? (Select all that apply)








How long, on average, do you stay at Community Park when you visit?










Do you use this amenity or function?






Which FOUR of these amenities and/or functions are the MOST IMPORTANT to your household?




Which FOUR of these improvements are the MOST IMPORTANT for the City to add/ expand/ renovate?











What type of accommodation is needed to serve individuals with disabilities in your household? (Please check all that apply.)








What types of programs are desired to serve individuals with disabilities in your household? (Please check all that apply)







How would members of your household prefer to receive information about future Poway Community Park programs and services? (Please check all that apply.)





Considerations: Update Existing

- 1. Add additional Shade structures
 - Tot lots / Splash pad + Grass Area / Baseball field area / Parking lot to the park
- 2. Improve Signage (Directional and Informational)
 - Entrance / Amenities / Rooms / Wayfinding
- 3. Connect Pedestrian loops and enhance ADA accessibility
 - Mile markers / Wayfinding
- 4. Upgrade play structures to all-abilities playgrounds
- 5. Increase safety lighting in and around the park







Considerations: New Amenities

- 1. Add outdoor adventure elements
- 2. Add dedicated Pickleball courts
- 3. Add restroom(s) by play areas
- 4. Introduce interpretive learning opportunities to activate the creek
- 5. Provide fitness equipment / exercise stations along on the trail







Considerations: Operations

1. Invest in additional marketing to create greater awareness

- 2. Focus on maintenance Improvements
 - Relocate maintenance yard; add dedicated staff / contract support
- 3. Ensure consistency in branding and aesthetics
- 4. Determine consistent hours of operations
- 5. Utilize technology to enhance the user experience
 - E.g. Wifi, App for accessible maps / parking counts/ workout trackers etc.

- 2. Accessible Trails and Connectivity
- 3. Signage
- 4. Additional Resources (Staff and/or Contract Support)
- 5. Adventure Amenities and All-Abilities Playground


